4. I understand that I will receive an email or phone confirmation of my winning bid to the information submitted no later than May 24, 2010.
5. I understand that it is my responsibility to arrange pickup of my winnings with Monica Reeves, Auction Chair.
6. I understand that any Proxy Bid Form containing any qualifying statements attached to any item will not be accepted. For example, you may not state: "Subject to my approval," "If there is no scheduling conflict," or "If the performance is on a weekend."
7. I understand that the Korematsu PTO Auction Committee reserves the right to refuse any proxy bid for any reason, including but not limited to proxy bids that are lower than the minimum starting bid for an item.
8. I understand that my submission of the Proxy Bid Form is final. I understand that I may not alter this proxy bid, which I have submitted for proxy bidding in any way, including the authorized maximum bid amount. It is recommended that I make a personal copy of this entire, completed form, prior to submission.
